Please read the following CAREFULLY before signing:

1. I understand that I am entering into a binding contract between myself and Cenla Cat Project (CCP) for adoption of the above-described cat. I have read this entire contract CAREFULLY before signing it. I agree that said cat shall not be used for medical or any other experimental purposes whatsoever. I agree that this cat is being adopted as a family pet. He/she will have extensive house privileges and will not be kept outside. I agree to provide this cat with proper food, water, shelter, and veterinary care. I further agree that this cat will not be declawed.
2. This cat has received age-appropriate core vaccinations, but I understand that CCP is not making any representations or warranties regarding the cat's health, physical condition or age. I understand that veterinary problems may arise with this cat, including serious illnesses requiring emergency care or surgery, that those problems are my responsibility, and that I will bear all related costs and will provide the proper veterinary care to the cat in a timely manner.
3. I agree that CCP has the right to make a visit at a mutually convenient time to ascertain that all of the above conditions are being satisfied. If CCP contacts me to inquire about the cat, I agree to make a good faith effort to return CCP's call as soon as possible.
4. If I change my address/telephone number. I will notify CCP within three (3) weeks of the change.
5. If I can no longer keep the cat, I will notify CCP IMMEDIATELY and make arrangements to return the cat to CCP. I understand that the adoption fee is non-refundable unless I request a refund within 30 days from the adoption date shown above (unless otherwise stated in the "Remarks" of the form). Under no circumstances will I give the cat to a 3rd party or take the cat to a shelter.
6. I understand that CCP may reclaim the cat if, in its sole opinion, any of the above conditions are not being met. I understand that I will be liable for any fees and costs incurred by CCP arising out of the enforcement of this contract.
7. I understand that CCP makes every attempt to ensure that I am adopting a healthy cat and that all CCP's cats have vaccinations as well as monthly worm, ear mite, flea prevention and their health is monitored closely by CCP's volunteers or staff who contact local veterinarians when necessary. However, I also understand that the stress of relocating this new pet into my home may cause a feline illness to surface regardless of all CCP's efforts.
8. I understand that change is difficult for cats. When the above-described cat is moved from the CCP Shelter/Foster into my home, he/she will need a period of adjustment in order to feel safe and comfortable in his/her new surroundings. I understand, that the time necessary for this adjustment period will vary depending upon this particular pet's personality.
9. I understand that CCP is not making any representations or warranties about the cat's temperament or behavior. I acknowledge and agree that CCP is not responsible for any injury, damage, or harm caused by this cat, and I hereby release CCP from any and all liability for any injury, damage, harm, expense or liability I incur relating to this cat. I also agree to indemnify CCP from any and all such claims and to pay, without limitation, any costs related to such injury, damage, or liability, including, in the case of litigation, any attorney's fees incurred by CCP in its defense.

BY SIGNING THIS APPLICATION AND CONTRACT, I CERTIFY THAT ALL INFORMATION IN THIS APPLICATION IS TRUE, AND I UNDERSTAND THAT GIVING FALSE INFORMATION MAY VOID THE CONTRACT RESULTING IN FORFEITURE OF THE ADOPTED ANIMAL. I FURTHER UNDERSTAND THAT THIS CONTRACT IS INTENDED TO BE A COMPLETE STATEMENT OF THE UNDERSTANDING BETWEEN CCP AND ME, AND THIS CONTRACT MAY NOT BE MODIFIED EXCEPT IN WRITING AND SIGNED BY BOTH PARTIES
